## ITEM

\* The ECE Executive Secretary will participate remotely.

(1) The costing of travel is based on the travel mode and standard according to the United Nations rules.

(2) The price of tickets is estimated and has been provided by UN Carlsson Wagon-Lit Travel Agents based in Palais des Nations.

(3) The DSA and terminal expenses include travel time and pre-and post-meeting preparations. The number of DSAs may be subject to changes depending on the travel dates. The DSA is reduced by 50% with the understanding that the host Government will provide accommodation free of charge. The actual amount of DSA to be paid shall be subject to the actual United Nations DSA rate in effect at the time of travel.

(4) The full terminal expense is normally US\$ 47 per point of departure/arrival. If the Government provides transportation between airport and hotel and conference facilities in Vilnius, the terminals will be reduced to \$14 on arrival and \$14 on departure. The actual amount of the terminals to be paid shall be subject to the actual United Nations terminals rate in effect at the time of travel.

(5) The Government should handle directly administration and payment for the costs referred to in para. 3 of the host country agreement; provide prepaid return tickets to the UNECE officials, as set out in para. 4 (a); and arrange for the shipment of materials referred to in para 3 (c) of the agreement with no costs to UNECE. The funds for the payment of DSAs and terminals referred to in para. 4 (b) should be transferred to the UNECE Trust Fund for the Espoo Convention well in advance of the travel dates, upon acceptance by the Government of Lithuania of the arrangements set out in this letter, and include 13% of programme support cost and 10% contingency.
