The recent visit of General Police Inspectorate representatives to Lithuania demonstrated the progressive capabilities and the true values of the Lithuanian Police, aimed at ensuring human rights and freedoms.

We sincerely thank you for the opportunity to take over the good practices of your institution. The last week study visit opened new opportunities for strengthening the institutional capacities of the National Police in the context of European integration.

Since February 24, 2022, our country is facing difficult times directly related to the military conflict in Ukraine.

The war at our borders, on the one hand, contributes to an unstable and unpredictable situation in the region against the backdrop of an energy crisis and threats to territorial integrity, on the other hand, the situation is aggravated by the anti-government and anti-European aspirations of the opposition in order to destabilize the situation inside the country.

In terms of external and internal security of the country, a particularly sensitive and vulnerable area for the Republic of Moldova is the Transnistrian region.

Over the past year we have addressed the challenges, but considering the escalation of the war in Ukraine, we must continue to make considerable efforts should be taken in order to adequately counter current risks and threats, such as hybrid and cyber attacks, trafficking in human beings, drug and arms trafficking, money laundering, search for wanted persons, as well as to be prepared for a new refugee crisis and other difficulties.

In these extraordinary conditions, the Moldovan Police is working on high alert, by increasing the presence in the community and monitoring the state of play, but the situation is exacerbated by the additional problems associated with the staff flow, the lack of time for appropriate training and the unattractiveness of police service.

To respond appropriately to all kind of challenges, we need to use modern technical solutions and equipment that will improve the existing situation.

In this context, we kindly ask for your support in overcoming the current crisis and considering the possibility of providing the Police of the Republic of Moldova with assistance in the form of technical means, equipment and vehicles, etc.

In these difficult times any kind of support is important for us.

I believe that our long-term and strong partnership will help us overcome all the above mentioned challenges.
