The Ministry of Foreign Affairs of the Republic of Lithuania presents its compliments to the Embassy of the United States of America in Vilnius and has the honour to confirm the receipt of the Embassy's Note No. 117/2025 dated August 25, 2025, concerning the proposal to amend the Agreement between the Government of the Republic of Lithuania and the Government of the United States of America on the Legal Status of an International American School in Vilnius, done at Vilnius on June 14, 2002, as amended ("the 2002 Agreement"), which reads as follows:

Beginning of the quote. The Embassy of the United States of America presents its compliments to the Ministry of Foreign Affairs of the Republic of Lithuania and has the honor to refer to discussions between representatives of the two Governments regarding the Agreement between the Government of the Republic of Lithuania and the Government of the United States of America on the Legal Status of an International American School in Vilnius, done at Vilnius on June 14, 2002, as amended ("the 2002 Agreement").

The Embassy proposes on behalf of the Government of the United States of America that the 2002 Agreement be amended by adding a new Article 6 bis as follows:

Article 6 bis

1. The Contracting Parties agree that term of lease of the real property owned by the state or municipality that is or will be leased to the School in the Republic of Lithuania may be extended for ninety-nine (99) years, provided the lease of the real property is related to the establishment, organization, activities or educational purposes of the School.
2. The School may carry out, at its own expense, construction, renovation and maintenance of the real property leased. Any such actions by the School with regard to the real property leased are subject to the legal acts of the Republic of Lithuania.
3. Other specific details of the lease shall be determined in the separate lease between the owner of the real property and the School subject to the legal acts of the Republic of Lithuania.

If the foregoing proposal is acceptable to the Government of Lithuania, the Embassy proposes that this note and a reply note by the Ministry accepting this proposal shall together constitute an agreement between the Government of the Republic of Lithuania and the Government of the United States of America amending the 2002 Agreement (hereinafter "Agreement amending the 2002 Agreement"), which shall enter into force upon the date of notification by the Republic of Lithuania through diplomatic channels that it has completed all domestic legal procedures necessary for the entry into force of this Agreement amending the 2002 Agreement.

The Embassy of the United States of America avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Republic of Lithuania the assurances of its highest consideration. **End of the quote.**

The Ministry of Foreign Affairs of the Republic of Lithuania has the honour to confirm that the proposal by the Embassy of the United States of America in Vilnius on behalf of the Government of the United States of America is acceptable to the Government of the Republic of Lithuania and that the Embassy's Note No. 117/2025 dated August 25 2025 and this reply Note shall together constitute the Agreement amending the 2002 Agreement, which shall enter into force upon the date of notification by the Republic of Lithuania through diplomatic channels that it has completed all domestic legal procedures necessary for the entry into force of this Agreement amending the 2002 Agreement.

The Ministry of Foreign Affairs of the Republic of Lithuania avails itself of this opportunity to renew to the Embassy of the United States of America in Vilnius the assurances of its highest consideration.
