The Ministry of Foreign Affairs of the Republic of Lithuania presents its compliments to the Ministry for Foreign Affairs of Finland, and has the honour to confirm the receipt of the Ministry's note No. PC0TQ4CA-4 of 23 July 2020, concerning the **Agreement between the Government of the Republic of Lithuania and the Government of the Republic of Finland on the termination of the Agreement between the Government of the Republic of Lithuania and the Government of the Republic of Finland for the Promotion and Protection of Investments** (hereinafter - the *Agreement*) which reads as follows:

Beginning of the quote. The Ministry for Foreign Affairs of Finland presents their compliments to the Ministry of Foreign Affairs of the Republic of Lithuania and have the honour to propose the conclusion of the following agreement.

Agreement between the Government of the Republic of Finland and the Government of the Republic of Lithuania on the termination of the Agreement between the Government of the Republic of Finland and the Government of the Republic of Lithuania for the Promotion and Protection of Investments (hereinafter - the *Agreement*)

1. The Agreement between the Government of the Republic of Finland and the Government of the Republic of Lithuania for the Promotion and Protection of Investments, done at Vilnius on 12 June 1992 (hereinafter – the Agreement on the Protection of Investments), shall be terminated.

2. For greater certainty, the Contracting Parties to the *Agreement* agree that Paragraph (3) of Article 11 of the Agreement on the Protection of Investments, which extends the protection of investment made prior to the date of the termination, shall be terminated and thus shall not produce any legal effects after the entry into force of this *Agreement*.

The Ministry for Foreign Affairs proposes that in case the Government of the Republic of Lithuania accepts the above mentioned proposal, this note together with the reply note from the Government of the Republic of Lithuania shall constitute the *Agreement*. The *Agreement* shall enter into force on the thirtieth day after the date on which the Contracting Parties have notified each other that the constitutional requirements for the entry into force of this *Agreement* have been fulfilled.

The Ministry for Foreign Affairs of Finland avails themselves of this opportunity to renew to the Ministry of Foreign Affairs of the Republic of Lithuania the assurances of their highest consideration. **End of the quote.**

The Ministry of Foreign Affairs of the Republic of Lithuania has the honour to confirm that the proposal by the Government of Finland is acceptable to the Government of the Republic of Lithuania and that Note No. PC0TQ4CA-4 of 23 July 2020 and this reply Note shall constitute the *Agreement*, which shall enter into force on the thirtieth day after the date on which the Contracting Parties have notified each other that the constitutional requirements for the entry into force of this *Agreement* have been fulfilled.

The Ministry of Foreign Affairs of the Republic of Lithuania avails itself of this opportunity to renew to the Ministry for Foreign Affairs of Finland the assurances of its highest consideration.
